in the Indian Child Welfare Act of 1978, the U.S. Congress found "that there is no resource that is more vital to the continued existence and integrity of Indian tribes than their children and that the United States has a direct interest, as trustee, in protecting Indian children who are members of or are eligible for membership in an Indian tribe;" 25 U.S.C. § 1901(3); and

WHEREAS, it is the policy of the United States "to protect the best interests of Indian children and to promote the stability and security of Indian tribes and families by the establishment of minimum Federal standards for removal of children from their families and the placement of such children in foster or adoptive homes which will reflect the unique values of Indian culture . . ." 25 U.S.C. 1902; and
