A Resolution Opposing the Elimination of the Indian and Native American Department of Labor Workforce Innovation and Opportunity Act Funding in the President's FY 2020 Budget

## Resolution No. 19-12



WHEREAS, the Inter-Tribal Council of the Five Civilized Tribes (ITC) is an organization that unites the tribal governments of the Cherokee, Chickasaw, Choctaw, Muscogee (Creek), and Seminole Nations, representing approximately 750,000 Indian people throughout the United States; and



WHEREAS, the five tribes of the Inter-Tribal Council have been administering Department of Labor Employment and Training Programs for over four decades; and



WHEREAS, the Native American population has the highest unemployment and lowest educational rates of any United States population; and

WHEREAS, in FY2018, the five tribes of the Inter-Tribal Council received a total of \$4,286,398 in Workforce Innovation and Opportunity Act (WIOA)

funds from the Department of Labor; and



WHEREAS, these funds are necessary to provide Native Americans within our service areas the skills needed to obtain and retain good employment with self-sustaining wages and benefits; and

> WHEREAS, these funds provide needed services to thousands of Native Americans, both youth and adult; and



WHEREAS, the President's proposed budget would eliminate the Department of Labor, Employment and Training Administration, Division of Indian and Native American Programs; and

WHEREAS, the President's proposed budget would provide a 1.5% set aside to the states for Indian and Native American adults and eliminate funding for Indian and Native American youth; and



WHEREAS, the information upon which this decision is based is seriously flawed, stating tribal programs are "unproven, having never been rigorously evaluated" and demonstrates not only a serious lack of familiarity with tribes and Native Communities, but also ignorance of the immense effort put forth and difference made in native lives and communities by these programs.

NOW, THEREFORE LET IT BE RESOLVED THAT, the Inter-Tribal Council of the Five Civilized Tribes opposes the elimination of Indian and Native American WIOA funding as presented in the President's proposed FY2020 budget.

BE IT FURTHER RESOLVED THAT, the Inter-Tribal Council of the Five Civilized Tribes urges Congress to reject the President's FY2020 and fund WIOA at a level not less than \$55 million dollars.
